- Interested companies can obtain Tender Documents including eligibility criteria upon payment of Tender Document Fee (non-refundable) through **PAY ORDER OR BANK DRAFT of Pak Rs.3,000/- (for each work)** in favor of **Sindh Solid Waste Management Board** as per schedule given above from the office of **Assistant Director (Finance)**, SSWMB during office hours. Alternatively the documents may also be downloaded from the website www.ppms.pprasindh.gov.pk or www.sswmb.gos.pk. The companies downloading the documents from the websites must submit Tender Document Fee in the shape of Pay Order or Demand Draft as mentioned above at the time of submission of the bid.
- Bid Security of amount equivalent to 2% of the total quoted bid amount must be attached with the bids in the shape of Pay Order / Demand Draft / Deposit at Call / Bank Guarantee issued by schedule bank of Pakistan.
- Proof of Registration with FBR (NTN / Sales Tax) and Sindh Revenue Board (SRB) is to be submitted with the bids.
- The Bids must be in sealed envelope and submitted SEPARATE FOR EACH WORK / SERVICES.
- The envelope must clearly state:
 - Name of the Work (e.g. Arrangements for Lifting, Transportation and Burial of Offals on the Occasion of Eid-ul-Azha for Orangi Zone of DMC West. and;**
 - Tender Reference Number as mentioned on the bid document (e.g. SSWMB/NIT.2.1/2020-21).**
- In case, the date of opening of bids is declared as a public holiday or non-working day due to force Majeure, the next official working day shall be deemed to be date for issuance, submission and opening of tenders. The time and venue shall remain unchanged.
- Sindh Solid Waste Management Board** shall not be responsible for any cost or expenses incurred by bidding firms and reserves the right to terminate the procurement process at any time subject to relevant provision of SPP Rules, 2010 (Amended 2019).
