SUBJECT: CANCELLATION OF WORK NO. 6.6 AND 6.8 UNDER RE-NIT-6/2019-20 (SPPRA PPMS SERIAL NO.00514-19-0005)

I am directed to refer to the subject cited above and to state that Sindh Solid Waste Management Board invited tenders for Lifting & Transportation of garbage from different districts (South, East, Malir, West, & Central), Karachi to Landfill Site' under RE-NIT-6/2019-20, which were published in leading, English, Urdu and Sindhi newspapers as well as uploaded at SSWMB and SPPRA Website (PPMS Serial No. 00514-19-0005). The works for lifting of garbage of district South (6.1), East, (6.2), Malir (6.3), Baldia Zone of District West (6.4), Kemari Zone of District West (6.5), Orangi Zone of District West (6.7), New Karachi & North Nazimabad of District Central (6.9) have been finalized in the light of SPPRA Rules, 2010 (Amended 2019). However remaining 2 works, i.e. SIE Zone of District West (6.6) and Gulberg & Liaquatabad Zone of District Central (6.8) were not finalized due to higher side of quoted rates by the bidders as compared to estimated cost.

2. The SPPRA under Rule-25(1) empowers the Procuring Agency to cancel the work at any time prior to the acceptance of bid or proposal, therefore, with the approval of the competent authority, SSWMB is hereby cancelling the 2 remaining works regarding Lifting & Transportation of Garbage from GTs & other areas (designated dumping points & katchra kundis etc.) of SITE Zone District West to Landfill Site (Re-NIT-6.6) and Lifting and Transportation of Garbage from GTs & other areas (designated dumping points & katchra kundis etc.) of Gulberg & Liaquatabad Zone District Central to Landfill Site (Re-NIT-6.8) under Re-NIT-6/2019-20.
