The companies downloading the documents from the websites must submit Tender Document Fee in the shape of Pay Order or Demand Draft as mentioned above at the time of submission of the bid(s).
- Bid Security of amount equivalent to 2% of the total quoted bid amount must be attached with the bids.
- Proof of Registration with FBR (NTN / Sales Tax) and Sindh Revenue Board (SRB) is to be submitted with the bid(s).
- The Bid shall comprise a single packet (outer envelope) containing two sealed separate envelope. Each envelope shall contain separately for the Technical Bid and Financial Bid duly sealed.
- The envelope must clearly state:
 - Name of the Work (e.g. Lifting & Transportation of Garbage from GTSs and other areas of District South, Karachi to Landfill Sites and;**
 - Tender Reference Number as mentioned on the bid document (e.g. SSWMB/NIT.1.1/2018-19).**
- In case, the date of opening of bids is declared as a public holiday or non-working day due to force Majeure, the next official working day shall be deemed to be date for issuance, submission and opening of tenders. The time and venue shall remain unchanged.
